62 members signed-in, there were approximately 10 more present, probably representing around 65 properties (see *Attachment # 2*)

For ease of reference, the Minutes are presented in Agenda order.

The President called the meeting to order at 9:34 a.m. and welcomed all participants to the Annual General Meeting of the Association, including our councillor and the mayor.

1.0 APPROVAL OF THE AGENDA

2.0 APPROVAL OF THE JULY 25, 2021 ANNUAL GENERAL MEETING MINUTES

3.0 PRESIDENT'S REPORT AND RECOMMENDATIONS

Constance began the meeting by inviting the Councillor of District 3, Claude Bergeron, as well as the Mayor, Jules Dagenais, to give updates on municipal affairs.

Claude Bergeron started by reporting the following developments:

Short-term rentals

- The municipal council was going to start implementing new regulations concerning short-term rentals beginning August 2nd.
- There will be public consultations on these new regulations.
- The first regulations will probably be put forward in early fall.
- At the moment there are no municipal rules, but the following are to be expected:
 - Raising of the permit fee to \$550 annually
 - Septic system requirements
 - Spacing out of short-term rentals (can't be next to each other)
 - The responsible person must live close to the rental
 - Parking requirements
 - Signage requirements
- Amendments to regulations could happen in the future, for example with respect to watercraft
- Everything will be published on the municipal website
- Other municipalities provide examples that could be used
- Fireworks remain separately regulated

Internet

- Digicom has been bought by another company and is currently installing fibreoptics by the end of September.
- The municipality will advise as soon as it is possible to hook up individual houses.

Jules Dagenais continued with the following information:

Consultation on waterways

- The week after the AGM the public consultations on waterways would start.
- This will be done in 3 phases:
 - Promotion on the municipal website and Facebook
 - In-person and online consultation on August 3rd
 - Online survey via the internet until the end of August

- A consulting firm will create a full report by the end of September for the municipality to consider.
- The mayor asks everyone to make themselves heard through the public consultation.
- The mayor had a meeting with the Quebec government, which is asking for more public access to waterways.
- In Val-des-Monts many lakes are surrounded by public land.

Claude continued:

- Claude is pushing for a public access to a lake with lots of public land around it for fishing and swimming. This is echoed by the mayor.
- There currently is no budget for a new park, and any park within the municipality would require significant capital investment to cover costs of sewage, pavilion, and parking.
- Officials are reviewing all the lakes within Val-des-Monts to determine where sufficient public land exists to merit such investment.
- Although the municipality owns a little piece of the Lac Bataille beach and some swamp land on the other side of the road, there are no plans to give public access to Lac Bataille.

Constance stressed that it is important that everyone participate individually in the survey to maximize impact. The Association already gives beach access to backlot members through the beach and is trying to buy the little piece of beach from the municipality to add it to the PSLL beach. The mayor added that the municipality can only restrict access to municipal land, not provincial land.

Question:

- How did the municipality obtain the land from the Hall brothers, and what is the benefit to this?

Answer Claude:

- The developer, the Hall brothers, had many lake access rights through deeds, which are still valid. However, this usually means foot access. When developers start projects, they usually must give 10% in value or land to the municipality for preservation purposes. This is how the municipality obtained the land. It was simply transferred.

Question:

- Are there studies from other municipalities on what happens to water quality and noise pollution when public access is given to lakes?

Answer Claude and mayor:

- Val-des-Monts has a water management plan, but the province is pushing for public access. The consultation is looking at all lakes to find the best solution. Claude is aware that Val-des-Monts has some of the cleanest water in the province, data is going back many years.

Claude and Constance stress once again that existing deeds provide only foot access to the lake, as does PSLL membership. The Association does not let in power boats through the boat launch, except for owners on Lac Bataille and Lac Rhéaume (if their boat fits through the culvert).

Question:

- Could the municipality install No-Parking signs at the beach?

Answer Claude:

- Maybe, but that would also prevent members to park at the beach.

Question:

- Do the mayor and the councillor support the creation of a public access on Lac Bataille?

Answer by Claude and the mayor:

- No. The priority is to maintain existing parks and accesses, there is no plan for any public access on Lac Bataille.

Question:

- Do we know what capacity the lakes have with respect to population and usage?

Answer Claude:

- The Val-des-Monts Lake Federation (FLVDM) had a study with respect to lake capacity, but the province thinks there are too many errors in the study.

One member commented that the Association is becoming an association of waterfront owners, and that some people from non-waterfront lots joined in the 1950s to have power boat access to the lakes.

The mayor and Claude concluded with the following points:

- The municipal council wants to hear from as many as possible during the consultation
- The current municipal strategic plan is to the year 2024, and there are many competing priorities (the province requires tri-annual plans)
- One of the big financial priorities is to fix the culvert on Chêne-Rouge.
- As for a No-parking zone except for members, it could be brought forward to the municipality to see if it is possible to enforce
- Claude also stressed that the notaries are required to advise new owners on tree-cutting restrictions and water-access restrictions. Any violation should be reported to the municipality via the councillor.

Constance concluded by asking any member that wants any speed signs (road or water) to contact the Association to gather a list.

She also stressed that the Association will continue in its request to buy the land, and that the municipality has not said no, but that it is considering it.

Constance also reminded members that there are member stickers for cars this year to identify parking members at the beach.

4.0 TREASURER'S REPORT

4.1 2021 Financial Statements

Jeff Hannah briefly reviewed the *2021 Financial Statement* (see Attachment #1). Altogether, we came in a little short last year, and this year we are projected to get even (see budget section).

A suggested fence for the beach section might be very expensive and not mor effective than the hedge that was planted last fall and need a little time to grow.

A question about fish stocking came up, and Jeff mentioned that the majority of it is actually paid by members as extra contributions.

A brief discussion ensued when Jeff and Constance said that the board is considering raising the annual membership from \$45 to \$50 per year. However, it became very quickly clear that the overwhelming majority favoured to raise the yearly membership to \$60.

5.0 REPORTS FROM THE BOARD COMMITTEES

5.1 Communications

Constance Hudak thanked the publication team for the *Newsletter*, especially editor Cynthia Hamady, all contributors, Odette Surch as translator, and everyone else who helped. She also thanked Jens for the work on the website and the email blasts.

5.2 Property Holdings and Issues

John Smith briefly explained the small sale of a piece of Association property on chemin des Sittelles (an undeveloped piece of road) to one of our members.

He also informed the membership of an ongoing issue on chemin des Chouettes with respect to a right of way on some undeveloped piece of the road. The Association is currently consulting neighbours on the proposal.

5.3 Environment

The Conservation Perkins-sur-le-lac group members Colette Labreque-Riel and Cory Bialowas thanked the Association for their assistance. The group is now registered as a charity and is creating a network for its goals. Donations are therefore tax deductible and at the moment 10 board members represent 7 lakes. The website can be consulted for all details on how to donate and how to get involved: conservationperskins-sur-le-lac.ca.

Chris Hemmingway from the Environment Committee reported that the water quality results this year are once again excellent, and he thanked all residents and volunteers. He also thanked the municipality for the strict septic tank policies and measurements.

Claude and Chris reminded everyone to use the new municipal boat washing station. It is free this year, and a second station is planned.

Question:

- What happens to the dust from the roads that goes into the lakes?

Answer Claude:

- The roads are treated during the summer, and the municipality is trying to get more of them paved.

Richard Bourassa reported that this year there was much more water testing, since the municipality is contributing in year 2 of a 3-year program. However, the Association still pays for *e.coli* testing, which is around 85% of the yearly cost. After year 3, we can decide if we stick to the more precise testing cycle or revert to our old testing pattern. Phosphorus is within acceptable norms, although some members noted that there might be more visible algae this year.

André Cossette reported that COBALI is doing a study on invasive species on our lakes, and a few volunteers are still needed to help. Last year's fish stocking stood at \$2,500 from the Association plus \$4,570 extra from the members.

5.4 Membership

Jeff reported that last year we hit the goal of 300 members and are expected to do so again this year.

5.5 Recreation and Social Activities

Constance suggested to do the annual corn roast, COVID restrictions permitting.

6.0 ELECTION OF THE BOARD OF DIRECTORS

- a) Richard Legault chaired the election. It was suggested to add one more member to Lac Bataille since there was a volunteer and always a vacant seat on Lac Chevreuil.
- **John Smith** was nominated as *Vice-President* by for a two (2) year term by Constance Hudak and Elaine Carisse.
 - **Jeff Hannah** was nominated as *Treasurer* for a two (2) year term by Jens Urban and Constance Hudak.
 - **Jacques Bolduc** was nominated as *Bataille Lake Representative* for a two (2) year term
 - **Sarah Adam-Black** was nominated as *Bataille Lake Representative* for a two (2) year term by Jacques Bolduc and Jens Urban.
 - **Joel Petit** was nominated as *Rh eume Lake Representative* for a two (2) year term by Justine Akman and Rick Murphy.
 - **Aileen Lamont** was nominated as *Rh eume Lake Representative* for a two (2) year term by Jens urban and Constance Hudak.
 - **Cynthia Hamady** was nominated as *Barnes Lake Representative* for a two (2) year term by Jens Urban and Constance Hudak.
 - **Chris Hemmingway** was nominated as *Lac Truite Representative* for a two (2) year term by Jens Urban and Constance Hudak.
 - **Andr  Cossette** was nominated as *Lake Louise Representative* for a two (2) year term by Rick Murphy and Constance Hudak.

All the candidates were elected by ACCLAMATION.

- b) Chevreuil Lake remains without representation.

7.0 OTHER BUSINESS

Requests for signs advising drivers of people walking along the road can be requested from the municipality through the councillor. Claude stressed that all roads except Blackburn will switch to 40 km/h speed limits.

Everyone was also reminded not to walk on Lauzon land.

There being no further business, the Annual General Meeting was adjourned at 12:00 p.m.
